Happy Birthday to the Security Industry Authority

On the 02nd April the SIA celebrated 10 years as the regulator of the UK's private security industry. Established as a result of industry lobbying and created by Parliament with the Private Security Industry Act 2001, it's core purpose was to contribute to the Home Office's crime reduction agenda: with the vision to reduce criminality and raise standards in the private security industry so that the public is, and feels, safer. It was launched in London on 2 April 2003 and since then it has worked with the industry to: license individuals, recognise excellence with the Approved Contractor Scheme, prevent unsuitable people from working in the security industry, and to ensure that those individuals who flout the law are removed from working in licensable roles.

Door Supervisors Licence Training Update

Since February, anyone renewing a Security Industry Authority (SIA) door supervision licence with a qualification from before June 2010 must also hold the up-skilling for door staff award, or renew to a security guarding licence that does not need the extra training.

The change means that door supervisors need to complete training in physical intervention skills as well as demonstrating knowledge in areas of first aid, awareness of terrorist threats and considerations in dealing with children and young people.

The SIA says that it has written to door supervisors whose licences are nearing renewal to explain how to renew their licence. The regulator says that it's seeing a number of people trying to renew their licence without the up-skilling qualification.



Anyone not meeting the qualification requirement will not be able to renew their door supervision licence, and they will not be able to work legally as a door supervisor.

Any officer that this affects and who would like to know where to go to get the necessary training updates should contact the Shield Security HR department for further information.

In our last edition we reported that the SIA Chairman, Baroness Ruth Henig was not staying on the role when her second term ended in January 2013.

Following her departure, the SIA announced that an Interim Chairman had been appointed and that this was Mr Bill Mathews. Mr Mathews, who has served as Scottish Board Member of the SIA since 2008, will hold the role for one year and one of his main duties will be to lead the regulator through the transition to the forthcoming new business licensing regime.

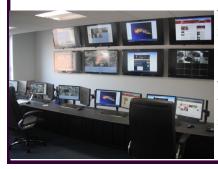


From the outside, we've made sure that the building leaves nobody in any doubt that Shield Security are based here.
